After careful examination of the proposals received from the Mandal Educational Officer, Vuyyuru vide reference 3rd & 4th cited and recommendations and conditions prescribed in Govt. orders read above, the competent authority i.e., the District Educational Officer, Krishna Machilipatnam is hereby accords Provisional Recognition to Pre-Primary classes (i.e., Nursery, L.K.G & U.K.G) from 2019-2020 to 2028-2029 to "Sri Viswasanthi EM School, Gandigunta Village, Vuyyuru" without aid subject to the following conditions:

- 1) that the society shall abide by the instructions/rules and regulations made by the Government of authorized Officer from time to time.
- 2) that the Educational Institution shall serve the needs of the locality more particularly.
- 3) that the Instructions shall adopt the curriculum and syllabus prescribed from time to time.
- 4) that the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
- 5) that the qualified staff within the age limits prescribed by the Government for Govt. Employees shall be appointed as per the staff pattern.
- 6) that the results of the institution shall be satisfactory every year.
- 7) that the records/accounts shall be furnished to the District Educational Officer every year by July at the latest.
- 8) that the list of Governing Body shall be furnished to the District Educational Officer every year.
- 9) that the pay structure/fee structure fixed by the Governing body shall be get approved by the District Educational Officer every year.
- 10) that all the conditions prescribed in the G.O.s and other orders which are not specified in this orders shall be complied with.
- 11) that the society shall submit proposals for Provisional Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
- 12) The management should obtain the renewal of fire certificate well in advance from the Fire Department.
- 13) Pre-Primary Schools are classified as Nursery, kindergarten, Montessori, and the like. They shall admit children who are in the age group of 3 to 5 years.
- 14) that the Teacher pupil ratio in respect of the Pre-Primary Schools shall not exceed 1:20 and in respect of all other sections the ratio shall not exceed 1:40.
- 15) that the Management should obtain latest renewal of Fire NOC issued by the competent authority immediately.

The Correspondent, Sri Viswasanthi (EM) Primary School, Gandigunta(V), Vuyyuru Mandal has applied for according Renewal of Recognition to Viswasanthi (EM) Primary School, Gandigunta(V), Vuyyuru Mandal during the year from 2019-2020 to 2028-2029.

The Inspecting Officer, i.e., the Mandal Educational Officer, Vuyyuru has caused inspection and submitted his report in the reference 7th cited.

After careful examination of the proposal from the Society and also the Inspection Report of the Inspecting Officer in the reference 6th cited, permission is hereby accorded for Renewal of Recognition to Sri Viswasanthi (EM) Primary School, Gandigunta(V), Vuyyuru Mandal with classes I to V (EM) during the year from 2019-2020 to 2028-2029 only subject to the following conditions:

1. That the society shall abide to the rules and regulations made in the Government order third cited.
2. That the society shall provide the necessary amenities like accommodation, sanitary facilities, drinking water facilities, furniture, library, laboratory equipment, play field, required staff pattern and other facilities are necessary before approaching the competent authority.
3. That the Opening permission accorded in restricted for the academic year 2019-2020 only and it is not valid for the subsequent academic year.
4. That this permission does not confer any right on the society for claiming recognition.
5. That the permission is accorded to "Educational Society of Teaching Sister's, Munagalapalli, Chandarlapadu Mandal", Krishna District and no other society or body can open a school on their behalf.
6. That the permission is accorded to open the school premises in the locality and there shall not be any change in the premises of locality.
7. That the Society shall provide the necessary material even if it costs more than the deposit amount.
8. Qualified staff should be appointed as per G O Ms. No.1, Education Department, dt.1-1-1994 with the prior approval of the District Educational Officer, Krishna, Machilipatnam.
9. To pay the salaries to the teachers from the management own funds without insisting for Government Aid to the Unaided posts.
10. Parents Teachers Association should be formed as per G O Ms. No.216, Dated. 17.10.1986 and Governing Body as per G O Ms. No.1, Education Dept. Dated 1-1-994, and G O Ms.No.41, Education, Edn.(PS) Dept, Dt. 2-7-2005.
11. State syllabus should be followed.
12. Should collect fee as per Government instructions.
13. Proper and adequate safety measures shall be taken for children with in the school campus and also near to the school premises.
14. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments. The Mangement has to submit the fire NOC to this Office in due course immediately.

15. All other conditions as per G O Ms. No.1, Education Dept., Dt.1-1-94 should be filled & all other conditions prescribed by the Government from time to time.
16. The Roll and Attendance should be improved.
17. They Shall have first aid kit and teacher shall be trained in first aid.
18. The correspondent of the concerned school is hereby inform to file an affidavit to the effect the there is no deviation or violation of norms / prescribed by the Government from time to time.
19. The management has informed that the permission now accorded on subject to condition for production of the Fire Certificate & other documents as per their undertaking.
20. Fire certificate issued by the District Fire Officer, Vijayawada should be produced within one month from the date of receipt.
21. All conditions as per G.O.Ms.No. 1, dated 01.01.1994 should be fulfilled, otherwise permission will automatically cancelled.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada who is the competent authority for Secondary Schools hereby grants Renewal of Recognition for the classes VI to X (EM) for 10 years from the academic years from 2019-20 to 2028-29 in Sri Viswasanthi (EM) High School, Gandigunta (V), Vuyyuru Mandal, Krishna District under the management of Viswasanthi Educational Society, Vuyyuru. 4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
5. That the results of institution shall be satisfactory every year
6. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer every year.
8. That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Ednl. Officer every year.
9. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.

10. That the school shall not be closed without giving notice both to the parents/DEO & competent authority at least 6 months before
 11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
 12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
 13. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
 14. The management informed that no thatched roof accommodation is allowed to run the School.
 15. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
 16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
 17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
 18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
 19. The school shall have first aid kit and the teachers shall be trained in first aid.
 20. The Correspondent of the concerned school is hereby informed to file an affidavit before 30th of April every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
 21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail to the inspecting officer.
 22. That the management shall ensure the Accounts of the school audited by an authorized Chartered Accountant every year and submit the same to this office along with Annual Administration Report without fail.
 23. That the management has to maintain trained teachers at all time.
 24. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
 25. That the Management is informed to obtain and submit the NOC issued by the Fire Services Dept authorities concerned from time to time without any interruption to the recognition period without fail to the Inspecting officer
 26. To follow the rules and regulations prescribed in Circular Memo No. 21748/D1/97, Dt: 16.02.1998 and other orders of /Transport authority regarding maintenance of school vehicles/maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport Authorities as prescribed by the Government from time to time.
 27. The preventive measures regarding maintenance of school vehicles/maintenance of vehicles to ensure safety of children as instructed in Pr..Rc.No.276/PS-1/2014-2, Dated.19.06.2015 of the C.S.E., AP, Hyderabad should be followed.
